Exam Format

The Foundation Certificate exam is held on the afternoon of Day 3. This Certificate is a mandatory pre-requisite if you are intending to take the Practitioner module:

- Multiple-choice
- One hour duration
- 75 questions
- A score of 50% correct is required to pass
- Closed-book

The Practitioner Certificate exam is held on Day 5 of the program:

- 8 questions with 10 answers each, for a total of 80 marks
- Pass marks will be 55% (44 right answers) for a pass, and 66% (53 right answers) for an elevated score
